- The WMATC operating authority of each carrier that has not filed a complete annual report and paid its annual fee and any assessed late fees will be automatically suspended effective May 2, 2013.
- Filing an annual report containing false information, or omitting information, may result in the assessment of a civil forfeiture.

2013 Annual Report, Annual Fee, and Late Fee Status

Dear Mr. Battellani:

Each carrier holding a WMATC Certificate of Authority on January 1, 2013, was required to file a complete 2013 annual report and pay a \$150 annual fee on or before January 31, 2013.

According to our records, the Commission still has not received a complete 2013 annual report from Carrier No. 1760. In addition, under Regulation No. 67-03, respondent also owes \$150 in late fees for failure to meet the filing deadline.

If Carrier No. 1760 fails to pay the assessed late fees and file a complete 2013 annual report by **May 1, 2013**, its operating authority will be automatically suspended, effective May 2.

A carrier may be subject to fines up to \$5,000 per day if it is found to have knowingly and willfully operated within this Commission's jurisdiction while suspended.

You can e-file your annual report and pay late fees online using a debit or credit card by logging into the Commission's e-filing system with your company's username and password.
