**RULES AND OTHER PROVISIONS WHICH GOVERN THE TARIFF**

**ITEM 110**

**DEFINITION**

The following "DEFINITION" reflects the technical interpretation of words and phrases used in this Tariff . Wherever such words or phrases are used they are designated by capitalization and quotation marks.

**CHARTER VEHICLE :**

A unit of motor passenger equipment assigned to the exclusive use of a party of persons.

**CHARTER PARTY :**

The term " CHARTER PARTY", As used herein, means a person or Group of persons, who pursuant to a common purpose, and under a single contract and at a fixed charge, have acquired the exclusive use of a passenger carrying motor vehicle, to travel together as a group to a specified destination of for a particular itinerary , either agreed upon in advance, or modified by the "CHARTER PARTY" after having left the "Place of Origin".

**CHARTER TRIP OR CHARTER MOVEMENT :**

Transportation and incidental service furnished by the carrier in a "CHARTER VEHICLE" between points authorized herein.

**HOUR :**

As used herein ,an "HOUR " is each 60 minute period ( Or fraction thereof), beginning at the time the "CHARTER VEHICLE" Departs the carrier's facility at Herndon Virginia until its return.

**PLACE OF ORIGIN :**

The term "PLACE OF ORIGIN", as used herein , means the place the where the "CHARTER PARTY" passengers are picked up by the "CHARTER VEHICLE" at the start of the "CHARTER TRIP".

**PLACE OF DESTINATION :**

The term "PLACE OF DESTINATION", as used herein, means the farthest most place where the "CHARTER VEHICLE" is vacated and released by the "CHARTER PARTY"

**ITEM 150**

**APPLICATION OF TARIFF**

- 1) This tariff applies to the transportation of passengers and their baggage, in CHARTER OPERATIONS.
- 2) Charges shown herein are in DOLLARS and CENTS and are payable in lawful United States currency.

**ITEM 160**

**APPLICATION AND COLLECTION OF CHARGES**

- (1) Charges shown herein, apply for "Charter Trips" over paved, macadam road, or roads over which the "Charter Vehicle" can be operated at the time of the Charter Trip with safety and without undue wear.
- (2) All Quotations are subject to the Carrier being able to supply equipment and apply only when the proper arrangements have been made for the furnishing of equipment and when the Carrier can properly meet with all the requirements of the City, State, National or State Park, Monument or reservations through which the "charter Vehicle" must pass.
- (3) When the Carrier for its own convenience furnishes a vehicle of a greater capacity or in a higher classification than that ordered, Charges for the "Charter Movement" will be based on the capacity or the Classification of the vehicle ordered. Charges must be assessed on the basis of the seating capacity, or the classification of the vehicle ordered at the time of quotation was made.
- (4) All charges for the Charter Trips are payable in advance, unless credit is established with the carrier.
- (5) All Charges for a "Charter Trip" must be assessed against and/ or collected from the person or organization ordering the "Charter Trip" and will not be prorated and collected from individuals.

**ITEM 170**

**BAGGAGE**

- 1) Personal Baggage will not be checked.
- 2) To the limit of capacity of the "charter vehicle", Personal effects, baggage, musical instruments, athletic equipment and other articles and paraphernalia, which are for actual use, or which are necessary or appropriate either for the wear, use, comfort and/or convenience of the passengers or for the purpose(s) of the "Charter Trip" will be transported at Owner's risk, at no additional charge.

**ITEM 325**

**ANIMALS OR BIRDS**

**No animals or birds will be carried.**

**ITEM 648**

**OBJECTIONABLE PERSONS**

**This Company reserves the right to refuse to transport a person or persons under the influence of intoxicating liquor or drugs, or who is incapable of taking care of himself or herself whose conduct makes him or her objectionable to other passengers.**

**EXCEPTION : Provision of this Item do not apply to person who are ill and accompanied by an attendant or nurse.**

**1. CLEANING VEHICLES:**

**When due to abuse or negligence by the Charter party, vehicles require extra cleaning (other than normal cleaning , etc .) there will be an additional charge of \$ 100 for cleaning each vehicle.**

**2 . TOLLS AND PARKING CHARGES**

**The charges herein do not include bridge, tunnel, ferry fees, or parking charges. Such charges will be paid by the party chartering the vehicles.**
