Tariff for Idea Travel Corporation

I. Application of Tariff

The rates, charges, rules and regulations contained herein apply to the transportation of passengers between points in the District of Columbia Metropolitan area.

II Rates and Charges

Carrier will assess hourly rates as follows:

A. Hourly Rate

- i) 7 passenger van \$50.00 per hour with a 4 hour minimum charge
- ii) 12 passenger van \$55.00 per hour with a 4 hour minimum charge

B. Other Charges

i) Cleaning Charge:

If in Carrier's opinion, the vehicle is left in a particularly dirty condition, a cleaning charge of \$50.00 will be assessed against the chartering party.

ii) Tolls, Fees and Special Charges:

The charges herein do not include bridge, ferry, tunnel or highway tolls, entrance fees or charges for special licenses or permits. An additional charge will be made for the cost of such tolls, fees or special charges.

iii) Damage Charge:

Vans are carefully inspected by the carrier prior to each charter trip. Any damage to a van caused by a chartering party shall be the responsibility of the chartering party, and the costs of Carrier for the repair of such damages shall be paid by the chartering party.

### III. RULES AND REGULATIONS

#### A. Availability of Equipment

Carrier reserves the right, when operating conditions so require, to furnish a vehicle of greater capacity, but charges will be based on the capacity of the vehicle ordered.

#### B. Baggage:

- (a) For charter trips, personal baggage, musical instruments, athletic equipment and other baggage will be transported in the custody of the chartering party at no additional charge.
- (b) Liability for loss or damage of baggage will be limited to \$50.00 for each individual.

#### C. Objectionable Persons:

Carrier reserves the right to refuse to transport a person or persons under the influence of intoxicating liquor or drugs, or who is incapable of taking care of himself, or who shows conduct which makes him or her objectionable to other passengers.

**EXCEPTION:** This does not apply to persons who are ill and are accompanied by an attendant or nurse.

#### D. Animals or Birds:

Animals or Birds will not be carried, except seeing-eye dogs accompanying their master.

#### E. Carrier's Liability:

Carrier will not be liable for delays caused by Acts of God, war, authority of law, quarantine, riots, strikes, accidents, breakdowns, road conditions, snow storms, or other conditions beyond carrier's control and does not guarantee to arrive at or depart from any point at a specified time. The carrier will endeavor to maintain the schedule submitted by its agents or employees, but same is not guaranteed.

F. Payment of Charges and Fees:

Payment of all charges and fees shall be the responsibility of the person or organization chartering the van. The carrier reserves the right to collect such charges in advance unless prior credit arrangements have been made with carrier.
