1. District of Columbia
2. Alexandria, Falls Church, Arlington County and Fairfax County, Va. and the political subdivision located therein
3. Montgomery County and Prince Georges County, Md. and the political subdivision located therein
4. Washington Dulles International Airport and all other cities

now or hereafter existing in Maryland or Virginia within the borders of the foregoing cities, county and airport

II. Rates and Charges

- A. 14 passenger bus-\$60.00 per hour with a 4 hour minimum
- B. 21 passenger bus-\$80.00 per hour with a 4 hour minimum
- C. One-way transfer from one point to another within a 25 mile radius at a flat rate of \$180.00 for 14 passenger and \$280.00 for 21 passenger bus
- D. Any Damage to seats, windows, or other equipment which is caused by any member of party shall be the responsibility of the party's group leader
- E. Carrier will not be liable for delays caused by weather, traffic and other things beyond Carrier's control
