***** A group is defined as 2 and no more than 5 clients ambulatory and or no more than one wheel chair from the same organization who are being simultaneously transported to the same destination

***** Pickup cancellations will incur a charge only when cancellation calls are received later than 30 minutes to the scheduled time of pick up, or upon arrival of the provider to the pick destination.

***** Airport group rates: add \$20.00 for each additional person being transported in an ambulatory van, or \$25.00 per person for wheel chair persons being transported from same point of origin to the same airport for up to 2 clients.

***** The mileage calculation for trips outside the capital beltway begins once the recipient is picked up for transportation.

***** Pick up delays (beyond the scheduled time of pick up) resulting from the client will incur a charge of \$20.00 per 15 minutes delay or fractions thereof, up to a maximum wait period of one hour after which the vehicle leaves. Where the van leaves after such maxed out delays by the client, the company is in no way responsible for the clients appointment on the same day.
