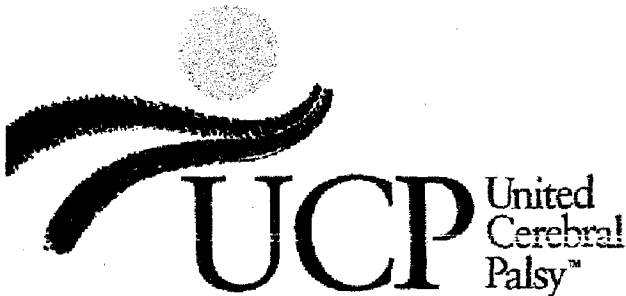


Re: Requesting Reconsider of Deemed Denial

To Whom It May Concern:

I was appointed the new Executive Director of United Cerebral Palsy of Washington & Northern VA. (UCP) Effective of November 5, 2007. UCP provides day habilitation services to 250 individuals with disabilities in the District of Columbia. UCP does not currently provide services in Virginia. The breakdown in our daily service rates are \$85.84 at the 3135 8th Street Location and \$97.38 at the 1818 New York Ave. location. Over 50 of the individuals receiving services have Medicaid Waiver funding which consists of a hourly rate of \$15.80. If those recipients that have Medicaid Waiver funding are present for 6 hours the daily the rate is \$94.80. Please reconsider UCP as a WMATC transportation provider. If you have any questions or require supporting documentation please contact me.
