**STATEMENT OF CARRIER'S RULES, REGULATIONS AND PRACTICES
THAT PERTAIN TO RATES, FARES, CHARGES, TRANSPORTATION AND
TRANSPORTATION RELATED SERVICES**

Rental of all vehicles with M&C Enterprise, Inc. ("Chariots For Hire") requires full acknowledgement and agreement of the following terms and conditions:

(1) Vehicle will not be reserved until a signed contract has been received by M&C Enterprise, Inc. along with a 25% non-refundable deposit.

(2) The remaining balance for a reservation must be received one week prior to reservation or reservation will be cancelled.

(3) No possession, sale or consumption of any type of narcotics or illegal drugs is permitted in any vehicle.

(4) Violations of (3) will result in immediate termination of contract and services and forfeiture of all paid deposits and fees for service.

(5) Possession of alcoholic beverages by a minor or in the presence of a minor not accompanied by the minor's legal guardian or parent is not permitted and will result in immediate termination of contract and cessation of services and forfeiture of all deposits and fees for service.

(6) Client and renter are responsible for any damage they cause to the vehicle, including unintentional damage. This includes but is not limited to: gum, wine and alcohol spillage, vomiting, breakage of champagne, wine and drink glasses, breakage of decanters, breakage of lights, television, VCR, radio, CD and DVD players.

(7) All passengers must behave in an orderly and well-behaved manner.



(8) M&C Enterprise, Inc. reserves the right to expel any person from the vehicle and/or terminate service in the event of a violation of any of the conditions in (3), (5), (6) and (7) by any passenger. In the event of such early termination, no portion of the rental fees shall be refunded.

(9) No smoking is permitted in any vehicle.

(10) M&C Enterprise, Inc. bears no responsibility for items that are left in the vehicle.

(11) M&C Enterprise, Inc. shall not be held responsible for late arrival caused by (but not limited to) acts of nature, traffic delays, breakdown, acts of terrorism, acts of God, incorrect pickup and drop-off information, and any situation beyond its control.

(12) M&C Enterprise, Inc. carries insurance as provided under Regulation No. 58 of the Washington Metropolitan Area Transit Commission. Client and renter hereby waive any and all claims against M&C Enterprise, Inc., its employees, officers, directors, agents or consultants resulting from any actions not covered by the required insurance or in excess of the required insurance.

(13) Client and renter hereby waive all claims against M&C Enterprise, Inc., its employees, officers, directors, agents or contractors for consequential or special damages resulting from any use of the vehicle or service.

(14) To the extent permitted by law, client and renter hereby waive any claims against M&C Enterprise, Inc. its employees, officers, directors, agents or contractors.

(15) In the event any part of this contract is declared unenforceable, the remaining provisions of this agreement shall remain in full force and effect.

(16) If the vehicle is to be by a minor under the age of (18) eighteen this agreement must be signed by either a parent or legal guardian over the age of (21).

(17) M&C Enterprise, Inc. requires 48 hours notice to cancel a reservation for a limousine or bus. Cancellation with less than required notice will result in a full charge, which will be placed on the credit card used to hold the reservation.

(18) Cancellation with more than required notice will result in loss of the 25% deposit. All deposits used to hold a reservation are non-refundable.

(19) Failure to cancel your reservation immediately constitutes acceptance of these terms and policies.
