CHARGES

Additional Passengers

- A \$17 fee will be assessed for each add'l passenger in excess of (2) passengers

Fuel Surcharge

- A 5% fee will be assessed to the total fare amount on Non-Airport Trips

Stop Offs

- A \$34 fee will be assessed for each stop off

Cancellations

- A fee of \$68 (1 hour minimum) will be invoiced when 24 hours or less of notice is provided

Luggage

- Each passenger will be allowed 2 pieces of luggage at no charge
- Each additional piece of luggage will be assessed a \$2 fee

Pets

- Must be crated and a \$10 fee will be assessed

Airport Grace Periods

- 30 minutes will be allowed from scheduled time of arrival for domestic flights
- 45 minutes will be allowed for international flights
- A fee of \$17 will be assessed for every 15 minutes or fraction thereof beyond said grace period

Holidays, Rush Hour, After Hours

- Additional 20% will be added to trips occurring on Christmas, New Years, Memorial Day, July 4th, Labor Day, Thanksgiving, and Easter
- Additional 20% will be added to trips that occur between 3:30 PM and 6:30 PM on weekdays
- Additional 20% will be added to trips that occur after 11:00 PM and prior to 6:00 AM

NOTE

- Fees are assessed from time of pick-up to return of final destination
- Parking and tolls are additional
