1. **General Applicability.** The rules and rates set forth in this tariff govern the provision of Private-Pay Ambulatory and/or Wheelchair services.
2. **Roundtrip Service** means a pickup of the passenger; transportation to a medical or other facility; and a return trip to the origin point of pickup.
3. **Trip Cancellation.** All rates and services are subject to a trip cancellation charge of \$85.00 if the trip is cancelled upon vehicle arrival at the point of pick up.
4. **Waiting Time.** All rates and services are subject to an additional Waiting Time surcharge of \$.75 (75 cents) per minute or any portion thereof. Waiting Time charges are calculated as follows:
 - 4.1 Van service pickup. Charges for Van Service shall include 15 minutes of free waiting time at origin pickup. After 15 minutes the Waiting Time surcharge shall apply.
 - 4.2 Van Service return trip waiting on roundtrip services. Charges for roundtrip service shall include 20 minutes of free waiting time for return trip pickup of the passenger. After 20 minutes the waiting time surcharge shall apply.
 - 4.3 Wheelchair service pickup. Charges for Wheelchair Service shall include 15 minutes of free waiting time at origin pickup. After 15 minutes the Waiting Time surcharge shall apply.
 - 4.4 Wheelchair serviced return trip waiting on round trip services. Charges for round trip service shall include 20 minutes of free waiting time for return trip pickup of the passenger. After 20 minutes the waiting time surcharge shall apply.
