



**Reservations:** Reservations will not be confirmed until the signed contract and a deposit of \$150 or 50% of the total contract price; whichever is greater is received by James Petty Limousine. Client understands that any changes made to the contract once it has been received by James Petty Limousine, may result in a price increase. A \$20 early or late pick up fee will be added to all rates for reservations between 12midnight and 6am.

**Damage Charges:** Vehicles are carefully inspected by Carrier prior to each trip. Any damage to seats, windows, or other equipment or parts of the vehicle which is caused by a passenger(s) shall be the responsibility of the passenger(s) and the cost to Carrier for repairs of such damage shall be paid by the passenger(s).

**Cancellation Charges:** Client understands a cancellation fee of \$150 or 50% of the total reservation, whichever is greater will be accessed if less than 24 hour notice is received and acknowledged by James Petty Limousine.
