

FIF TRANSPORTATION, LLC

NUMBER OF PASSANGERS:

Carrier will not transport passengers in excess of the seating capacity of the vehicle (4). Standing is deemed unsafe and will not be permitted.

CONDUCT ON VEHICLE:

No smoking, drinking or lewd behavior is permitted. Driver is in control of the vehicle and will determine proper behavior. Carrier reserves the right to refuse to transport any person under the influence of alcohol, drugs or any intoxicating substance(s), who, in the opinion of the Carrier, is not capable of being in control of him/herself objectionable to other passengers or prospective passenger. Any damage caused by passenger's behavior to the vehicle or equipment, such as, but not limited to: writing on, scratching, tearing or throwing up, will be the sole responsibility of the passenger.

TRANSPORATION OF PETS/OTHER ANIMALS:

All Seeing-eye dogs are allowed at no extra charge. Small pets may be allowed at the discretion of the carrier.

CARRIER'S LIABILITY:

Carrier will not be liable for delays caused by Acts of God, public enemies, authority of law, quarantine, perils of navigation, riots, strikes, the hazards or dangers of incidents to a state of war, accidents, breakdowns, bad conditions of the road, weather conditions, and other conditions beyond carrier's control. Carrier does not guarantee to arrive at or to depart from any point at a specified time. If any such condition make it, at the discretion of the Carrier, unadvisable to operate or continue to operate the vehicle, the Carrier shall not be liable there of, or caused to be liable for damages for any reason whatsoever. The Carrier is not liable for damages to property, passengers or others that result from the acts of passengers or third parties.

COLLECTION OF CHARGES:

FIF Transportation, LLC accepts payments in cash. Personal checks may be accepted with copy of a valid driver's license at the discretion of the Carrier. A \$30 fee will be charged for each returned check. Airport trips or trips costing over \$30 may be paid in advanced with either cash or credit cards. A 5% surcharge of the total amount due will be assessed for delinquent payments in excess of 30 days. If payment is not received after 60 days from the date of service, Carrier can seek legal relief as provided by the law to recover payment and expenses to such legal proceedings.

DEPOSITS AND CANCELLATIONS:

Airport trips require a non-refundable service deposit of \$75. A charge of one full hour (\$75) will apply when a vehicle responds to an Airport pick-up and the trip is cancelled without a three hour notice. A charge in the amount of the full trip will apply when a vehicle responds to a Point to Point trip and the trip is cancelled and the vehicle has arrived at the pick-up site. Carrier reserves the right to cancel any

reservation, and not be liable for, due to snow emergencies or severe inclement weather or any condition as stated above in "Carrier Liability."

WAIT TIME, EXTRA STOPS, TOLLS AND PARKING FEES:

Wait time: 5-minute grace period, \$1.00 per minute thereafter up to 10 minutes.

After 10 minutes: trip is considered cancelled and is subjected to a cancellation fee.

Add \$15 for each extra stop plus parking fees.

Add all tolls and parking fees of the trip to the total amount due for the trip.

An Hourly Fee of \$75 will apply in addition to the point to point fee, to cover wait time costs, when the passenger requests the carrier to wait at the drop off location for another ride or return trip and the wait time is longer than 10 minutes.

TRIP FEE SCHEDULE:

Wait Time Hourly Fee \$75 as listed above.

Airport Rates as listed below.

Mileage/Point to Point Rates as listed below.

NON-AIRPORT DAYTIME POINT TO POINT:

\$6.00 for First Mile

\$2.00 for each additional mile

Rounding up of miles after the first mile up to 15 miles:

0.1 to 0.5 miles for \$1.00

0.6 to 1 mile for \$2.00

For trips longer than 15 miles, \$3.00 for additional mile

0.1 to .05 miles \$1.50

0.6 to 1 miles for \$3.00

Snow emergencies add \$1.75 per 0.5 mile

Snow emergencies are considered when there are more than 2" of snow on the ground and/or icy and dangerous conditions reported by the local weather stations/channels.
