- After 30 Minutes of wait time for a transfer, there will be an hourly charge of \$90.00 an hour 2 hour minimum charged instead of the regular transfer rate.

Cancellation Policy: There is a 2hr cancellation policy for all SUVs. If you cancel service within the two hour window you will be charged a late cancellation fee of \$75.00 for transfers and 2 hour minimum charge for hourly jobs, and if you cancel 2 hours before your scheduled pick up time you will not be charged.
