





**Magic Carpet Tours Bus Service, Inc.
Tariff Schedule**



Magic Carpet Tours Bus Service, Inc., provides transportation services to the Washington DC metropolitan area to include Northern, Virginia, Washington, DC, and suburban Maryland areas. This service includes pickup and discharge of customers in the above mentioned areas. In addition, the transportation service includes pickup and discharge of customers in Washington, DC for touring of the downtown and historic tour area of all of Washington, DC.

Magic Carpet Tours Bus Service, Inc., has an hourly rate of \$110.00 per hour for transportation services for the Washington, DC metropolitan area for our 56 passenger motor coaches, \$100.00 per hour for our 51 passenger motor coaches.

Time is to be calculated from the time the charter coach arrives at the schedule pick up location at the beginning of the charter until the drop off of the charter group at the conclusion of the charter trip plus one additional hour for Garage/Travel time. Time is calculated as per hour or portion thereof.

Magic Carpet Tours Bus Service, Inc. has a charge of \$1,072.00 for Dulles Airport pick up and \$950.00 Regan National Airport. With a base originating point of Richmond Virginia.

Transfers:

At chartering party's request carrier will provide Transfer Service from one point to a second point, both within the Washington Metropolitan District.

The chartering party shall have 30 minutes free time after the pickup time it has specified to board the coach . If the chartering party is not ready for the coach to depart within the 30-minute free time, carrier shall assess for waiting time an additional charge of \$85.00 per hour or portion thereof.

Minimum Charge:

A minimum of five hours at the hourly rate per coach will be assessed when the application of charges listed does not equal that amount.
