Executive Signature Services, LLC (ESS) offers distinctive transportation services to the public. Our rates are determined by either and drop-off location or by the hour. The rate is a blend of the two rates, where stops are scheduled between and drop-off, determined in accordance with the rules of this tariff. The total service price includes Gratuity fee and customer selected options. The following sections state the tariff for the services offered by ESS.

### POINT-TO-POINT RATE:

Points-to- Point service charges are as follows:

Cleaning	If soils the vehicle as to render it in an un-presentable condition for further use; a cleaning fee of \$175.00 will be added.
Damage	Damage to any part of the vehicle caused by passenger(s) shall be the responsibility of passenger(s) and the costs to carrier for the repairs of such damages shall be paid by the passenger(s).
Optional Services	An additional charge will be assessed for Stops, Waiting Time, Tolls, Parking, and Off-Peak Charge. (see details below *)

Hourly services charges:

Base Rate	\$85.00 per hour, 3-hour minimum.
Cleaning	If passenger (soils the vehicle as to render it in an un-presentable condition for further use, a cleaning fee of \$175.00 will be added.
Damage	Damage to any part of the vehicle caused by passenger(s) shall be the responsibility of passenger(s) and the costs to carrier for the repairs of such damages shall be paid by the passenger(s).
Optional Services	An additional charge will be assessed for Stops, Waiting Time, Tolls, Parking, and Off-Peak Charge. (see details below *)

Above rates include Modest Driver Gratuity. Rates do not include parking. Wait time charge of \$42.50 applied in 30 minute increments and any fraction thereof after first 30 minute grace period. \$40 Off- Peak charge applies to trips beginning between 12am and 5am. Additional stop charge - \$45.00, applied to all vehicles. Two or more stops hourly rates apply. Cancellation policy: All cancellations for transfers booked must be received two (2) hours prior to contracted start time to avoid forfeiture of 100% of the estimated trip total.
