

GENERAL RULES AND REGULATIONS

(Continued)

RULE NO. 1 AVAILABILITY

Charges named herein are based on vehicles having sufficient seating capacity to accommodate the chartering party. All charges, unless accepted in advance, are subject to the carrier's ability to supply equipment.

RULE NO. 2 NUMBER OF PASSENGERS

Carrier will not accept for transportation passengers in excess of the seating capacity of the vehicle.

RULE NO. 3 BAGGAGE

Baggage will not be checked and will not be the responsible of the chartering clients personal baggage, musical instruments, athletic equipment and other paraphernalia necessary for purpose of the trip shall be transported without additional charge but shall be limited to the space available.

RULE NO. 4 SPECIAL CHARGES

A 20% chauffeur gratuity will be explained to the chartering parties prior to all start times and applied at the conclusion of all services rendered.

RULE NO. 5 PAYMENT CHARGES

All charges will be assessed against and/or collected from person or organization in charge of the group chartering the vehicle. Carrier reserves the right to collect all charges before departing from point of origin.

RULE NO. 6 CONDUCT PASSENGERS

Carrier reserves the right to refuse to transport any person under influence of liquor or drugs, or whose conduct is such as to make him or her conduct objectionable to any other passengers and drivers.

(Continued)

RULE NO. 7. ACCIDENTS AND DELAYS

The carrier will not be liable for delays caused by bad road conditions, snow storms or other conditions beyond its control and when such conditions prevail, do not guarantee to arrive at or depart from any point at any specific time. If conditions over which carrier has no control, such as weather, road conditions, or Acts of God make it, in of the carrier, inadvisable to operate charter service, either from point of origin or at any point en route, the carrier shall not be liable therefore, or be caused to be held for damages for any reason whatsoever.

RULE NO. 8 OVERAGES ADDITIONAL FEES

When the chartered parties incur time past the agreed contract end-time, an overage fee will be charged; at the agreed hourly rate prior to the start time. Charge for a full hour will begin at the completion of the first half-hour beyond the agreed contracted end-time; and continue as such for each following hour thereafter; also any further time consumed beyond reasonable of the contract end-time, will only continue at the sole discretion of the carrier and all decisions are final.

In the event the chartered parties require services beyond the night of the previous day and continue into the sunrise of the next day, the carrier/driver will receive payment for reasonable lodging and meals by the chartering parties prior to the lodging of the driver and will only continue after receiving reasonable rest to perform duties.

RULE NO. 9 START AND END TIMES

All start times will begin at the location given to the carrier set forth by the chartering parties prior to or at the time of all pickup location. All end times will conclude at the location given to the carrier set forth by the chartering parties prior to or at the time of drop-off location. Travel time is added if pickups and/or drop-offs are located outside of the company's service area. The service area is defined as being within The Metropolitan District.

RULE NO. 10 CANCELLATION POLICIES

A 25% non-refundable booking fee will be charged for all cancellations of appointments booked with DIVINE CHAUFFEUR LLC; 48 hours after contract agreement. A 100% of the total estimated trip cost for appointments booked with DIVINE CHAUFFEURS LLC; will be forfeited if cancellation occurs 2 hours prior to contract start time.

RULE NO.11 LIABILITY AGREEMENT

DIVINE CHAUFFEUR reserves the right to lease equipment from other companies and/or subcontracts in order to fulfill its agreement to its chartering parties, and shall not be liable for items left in any vehicles.

The chartered parties and its guest will be charged a minimum fee of \$200.00 for cleaning due to any unusual wear or repairs to the vehicle and its interior; to include vomiting and spills inside the vehicle.

The decision rest solely with the carrier and all decisions are final.

RULE NO. 12 SMOKING

The chartering parties as well as drivers are prohibited to ignite any tobacco products or any other flammable products of any kind that produce ignition or receive ignition inside of any and all carrier vehicles.
