DEPOSITS ARE NON-REFUNDABLE

Cancellations with less than 7 days' notice will be billed at 100% of Total Contract Price. This means you pay for all charges on the contract. By signing this contract,

you are authorizing Black Silk Transportation to charge your credit card for any of the following charges; deposit, cancellation fee, damages to vehicle, overtime and all other services rendered. **NO PERSONAL CHECKS WILL BE ACCEPTED FOR ANY TRANSACTIONS.**

RULES AND REGULATIONS

1. The Client must be able to be contacted at any time during the length of the contract.
2. No alcohol is to be consumed by anyone less than 21 years of age in or out of the vehicle during the entire time that the vehicle is under contract. In the event that under age drinking occurs, the driver is under strict orders to contact the Client immediately, and return all passengers to the pick-up location. **THE RENTAL TIME SHALL BE TERMINATED IMMEDIATELY AND NO REFUND.**
3. In case of shared expenses (i.e. proms, nights out...), the Client who reserves the vehicle is ultimately responsible for the total price of the vehicle which is due upon pick-up. Any agreements to share fees are between the Client and his or her guests and are not valid to this contract.
4. One additional destination within 5 miles of the pick-up address or the final destination is included in the contract price. Each additional destination will be \$25.00 per 15 miles.
5. **SMOKING IS PROHIBITED** inside of the vehicle at all times. A \$100.00 service charge will be incurred per incident. **NO EXCEPTIONS.**
6. A \$250.00 clean-up fee will be charged for spills and vomit in or on the vehicle.
7. Client agrees that if anyone in the party is found using any illegal drugs, fighting, or any other conduct, considered inappropriate by the driver, the driver is under strict orders to return all passengers **IMMEDIATELY** to the starting point or continue directly to the drop off point, whichever is closest. **THE RENTAL TIME SHALL BE TERMINATED IMMEDIATELY AND NO REFUND.**
8. Client agrees that the limousine company will not be responsible for any items left or the safe keeping of items left in limousine. The limousine company will not be responsible for any lost, damaged, or stolen property.
9. Client agrees that overtime will be billed at the same contracted rate and agrees to pay any overtime charges. Overtime will be billed in hourly increments. Client agrees to pay the driver the cost of all parking expenses, tolls, or overtime immediately.
10. Client agrees that a replacement vehicle (comparable to original reservation without guarantee of color) may be substituted in the event of any major mechanical issues, vehicle involved in accident, etc.

11. Client agrees that the limousine company shall not be held liable for any damages arising out of the limousine company's inability to perform due to inclement weather, mechanical or electrical difficulties, delays due to traffic conditions, or any unforeseen events beyond the reasonable control of the limousine company.
