

- b) Damage Charges: Vehicles are carefully inspected by carrier prior to each trip. Any damage to seats, windows, or other equipment or parts of the vehicle which caused by any passenger(s) shall be the responsibility of that passenger(s) and the costs to carrier for the repairs of such damages shall be paid by the passenger(s).

These charges include parking fees and 15 minutes waiting time. Additional waiting time will be charged \$15.00 every 15 minutes.
