b,	WAITING RATE: Waiting rate begins after 5 minutes the vehicle arrives and after that the waiting fee will be \$1 per minute for the first hour and then hourly rate apply	
5, OTHER CHARGES		
a,	Passanger(s) is responsible for Airport Fees, Parking, Tolls, and other out of pocket expenses during the trip.	
b,	Cleaning charge: If any passanger leave the vehicle dirt in the condition that not usable for use, a cleaning fee of \$100 will be assessed and added to that passanger or passangers.	
c,	Damage: Before each trips, vehicle inspected carefully by carrier.
