

## 3- Other Charges:

- a) **Cleaning Charge:** if in the carrier's reasonable opinion, any passenger soils the vehicle as render it in an unpreventable condition for further use, a cleaning charge of \$90.00 will be assessed against that passenger(s).
- b) **Damage Charges:** Vehicles are carefully inspected by carrier prior to each trip. Any damage to seats, windows, or other equipment or parts of the vehicle which caused by any passenger(s) shall be the responsibility of that passenger(s) and the costs to carrier for the repairs of such damages shell be paid by the passenger(s).
- c) **Tolls, fee and special charges:** the charge herein do not include parking, bridge, ferry, tunnel or highway tolls, entrance fees or charges for special licenses or permits. An additional charge will be assessed for the actual cost of such tolls, fees or special charges.
- d) **Changes en route:** If changes en route from the original movement are ordered by the party chartering the vehicle, any additional mileage resulting therefore will be computed upon the charges set forth herein.
