### **Rates, Fares and Charges**

#### **Hourly Rates**

15 Passenger Van - \$ 85.00 per hour

#### **Airport Transfers**

(IAD) Washington Dulles Airport to DC - \$130.00

(DCA) Reagan International Airport to DC- \$ 95.00

### **Payment of Charges and Fees**

- a) Payment of all charges and fees shall be the responsibility of the chartering party and shall extend personally to the individual entering in the charter agreement on behalf of the chartering party. The carrier reserves the right to collect such charges in advance unless prior credit arrangements have been made with the carrier
- b) Off-Peak season (not including proms, homecomings, New Year's Eve) there is a four (4) hour minimum.  
Peak season including: PROMS APRIL 15<sup>TH</sup> – JUNE 15<sup>TH</sup>, HOMECOMINGS OCT.-NOV., & NEW YEAR'S EVE there is a 6 hour minimum.

### **Objectionable Persons**

The carrier reserves the right to refuse to transport a person or persons who is believed to be under the influence of intoxicating liquor or drugs by the carrier, or who is incapable of taking care of themselves, or who shows conduct which is such, or is likely to be such, as to make themselves objectionable to other passengers. Drinking alcohol or the use of any illegal drugs or any other illegal activity will result in the termination of the charter immediately, without refund.

### **Objectionable Destinations**

The carrier reserves the right to refuse to enter premises or areas that in the sole opinion of the carrier may expose the driver or vehicle to delay, liability, injury or damage, including area such as sports and public event parking lots, unpaved roads, poorly lit areas, areas which may be the site of illegal activities or areas which seem to be of a private or restricted nature.

### **Animals**

Animals will not be carried, except trained service dogs accompanying a person with a disability

**Carrier's Liability**

- a) The carrier will endeavor to maintain the schedule requested, but it is not guaranteed. The carrier may cancel any charter, with the total liability of the charter limited to the value of the charter.
- b) The carrier will not be liable for delays influenced by factors beyond their control, including but not limited to, traffic, inclement weather, vehicle mechanical malfunctions and break-downs, driver or passenger illness. If factors beyond the carriers control have such influence that, in the opinion of the carrier, it is inadvisable to operate the vehicle or continue the charter, then the carrier shall not be held liable.

**Service Charge**

A 20% gratuity service charge will apply on all trips.

**Authorization**

By placing an order with Perfect 1 Transportation, LLC, you agree that you are aware of these terms and conditions and will honor all charges. You also represent that you are duly authorized to grant Perfect 1 Transportation, LLC authority to process service charges to your credit card and/or corporate account and will be personally any and all charges contracted by you.

**Miscellaneous**

All vehicles are non-smoking

**OTHER CHARGES****Waiting Time**

After the fifteen (15) minutes, a one-half (1/2) hour charge is assessed for each half-hour (1/2) of waiting time.

**Cleaning Charge**

If in carrier's reasonable opinion, any passenger or passengers so leave the vehicle as to render it in particularly dirty/soiled condition, a minimum cleaning charge of one hundred fifty (\$150.00) dollars of higher will be assessed to the chartering party on labor hours.

**Damage Charge**

Vehicles are carefully inspected by the carrier prior to and after each charter trip. Any damage to upholstery, carriage-work, electronics, accessories, windows or other parts And accessories of the vehicle that is caused by anyone or anything related to the charting party shall be the responsibility of the charter party. Becoming ill inside the vehicle shall be considered unintentional damage to the vehicle's interior and will result in a one hundred fifty (\$150.00) dollars charge to clean and "air out" the vehicle. Any upholstery damages or cleaning are extra. Smoking in our vehicles shall be considered intentional damage to the vehicle's interior and will result in a two hundred (\$200.00) dollar charge to clean and "air out" the vehicle.
