**Terms and Conditions:**

All charges are billed to the client's credit card unless other billing arrangements have been made. Tuxedo Black Limousine & Luxury Sedans will accept all major credit cards or cash.

Point to Point rates do not include the following: Chauffeur gratuity, parking, or tolls. Client will be charged \$15 for each additional stop.

**Hourly Service:**

Hourly service is \$65 per hour, with a two hour minimum charge. Service areas for hourly services include Arlington & Fairfax counties & the portion of Loudon county which Dulles airport is located. All cities located within Montgomery and PG counties of MD are also included in the service area.

**Cancellations:**

Tuxedo Black Limousine & Luxury Sedans will accept cancellations without a charge, up to two hours before the scheduled pick-up time. For Point-to-Point Service, a fee equal to the fare, and 20% chauffeur gratuity, will be charged. For Hourly Service, a fee equal to 2 hours of service and 20% chauffeur gratuity will be charged.

**No Shows:**

For Point-to-Point Service, a fee equal to the fare, wait time and 20% chauffeur gratuity, will be charged when the client does not show at the pre-arranged pick-up location.

Hourly Services: A fee equal to 2 hours of service and 20% chauffeur gratuity will be charged when the client does not show at the pre-arranged pick-up location.
