Point-to-Point mileage rate

In Maryland:

- The minimum amount charged is \$7 from prearranged pick-up site up to 2.5 miles.
- All trips over 2.5 miles are charged on a per mile basis, at **\$2.00** per mile plus a **\$2.00** base fee.

In DC:

- The minimum amount charged is **\$10** from prearranged pick-up site up to 2.5 miles.
- All trips over 2.5 miles are charged on a per mile basis, at **\$2.00** per mile plus a **\$4.00** base fee.

Extra Charges – on top of regular fare

- Wait time upon arrival at pick-up location starts accruing after 5 minute grace period and charged every 5 minute thereafter: **\$2**
- En-route stops per every 5 minute wait time: **\$2**
- Holiday Surcharge from noon to midnight on (Independence Day, Thanksgiving, Christmas eve/day, New Year’s eve/day): **\$3**
- Snow emergency when declared by the District of Columbia and/or Montgomery County and/or Prince George’s County in Maryland: **\$3**
