**Additional Charges:**

- A 20% Gratuity and 5% Admin Fee is added on top of all base rates; NO CHARGE IS HIDDEN
- A \$10 meet & greet fee is added for all services from Dulles Airport, and if requested DCA Regan Airport. This charge includes up to 30 minutes of waiting time, and parking fees. Additional waiting time will be billed at \$12.50 per each fifteen minutes or fraction thereof
- A \$10 surcharge will apply for all services originating between 12:01 AM & 5 AM for early/late pickup
- If applicable cost for Parking, Tolls, Extra Stops (\$12.50 per stop), and Waiting Time (\$12.50 per each fifteen minutes or fraction thereof), will be charged accordingly on top of the base rate.

**Cancellation & "No Show" Policy**

- There will be no charge for reservations scheduled between 9am - 11am, and then cancelled four (4) hours prior to the scheduled service
- Any other reservations scheduled between 12:01am - 8:59am must be cancelled twelve (12) hours prior the scheduled service.
- Late cancellations and/or cancellations without prior notification to Allways LLC will be charged \$25 for local service or \$50 for scheduled service from IAD plus any parking fees incurred while waiting.
- If a passenger is a "No Show" they will be charged for the FULL fare price.
