ADDITIONAL CHARGES & FEES

- Tolls & Parking: added at cost.
- Additional stop: \$30.
- Additional passenger (Shuttle Bus only): \$20 per passenger.
- Cancellations must be 24 hours in advance or a \$150 cancellation fee applies.
- Wait time above 15 minutes: \$15 per 15 minutes (School Bus) / \$10 per 15 minutes (Shuttle Bus).
- Mileage if destination not listed: School Bus \$8/mile (base \$125), Shuttle Bus \$6/mile (base \$100).
- Fuel surcharge: 5% and will remain in effect until **updated** tariff rates are filed with WMATC.

Payment Policy:

- Checks payable to Central Avenue Transportation Services LLC.
- Cash accepted in a sealed envelope.
- Credit card payments require an invoice; 3% processing fee applies.
- Payment is due the day of or before the trip unless other arrangements are made.
- Overdue accounts are subject to a 5% weekly service charge.
