Additional charges on all rates specified above:

2. Mandatory gratuity: 18% added at the end of each trip.
3. Waiting time: \$25 per 15 minutes after the initial waiting period of 10 minutes.
4. Stops requested by passenger on or off the designated route of a point to point trip \$30 per stop.
5. Surcharge for trips on federal holidays \$75.

Cancellation Policy: If the request for service is canceled:

at least 24 hours before scheduled pick up: Full Refund

at least 12 hours before scheduled pick up: 50% of the fare

less than 12 hours before scheduled pick up or no show: Charged 100% of the fare

Hourly Rate: \$150.00 per hour with a 4 hour minimum.

Cleaning Fees: If passenger soils vehicle to the extent that it becomes unpresentable for future use, a cleaning fee of \$500 will be applied.
