### **Additional Instructions**

- **Cleaning charge** - If any passenger soils the vehicle as to render it in an unpresentable condition for further use, a charge of \$100 will be assessed.
- **Damage charge** - Any damage to the interior or exterior of the vehicle caused by any passenger shall be responsible for the repairs of such damages shall be paid by the passenger(s).
- **Tolls, fees and special charges** - An additional charge will be assessed for the actual cost of tolls, fees or special charges.
- **Wait time fee** - \$1.00 per minute.

### **Cancellation:**

- **Two hours before scheduled pick up** - No charge
- **Within two hours of scheduled pickup** - 1/2 of base rate
- **No show/no cancellation** - Full charge applies
