

WMATC Tariff Submission – Irregular Route Transportation

1. Rates and Charges

Service Type	Base Rate (One-Way)	Per Mile (After 5 Miles)	Wait Time (Per 15 Min)
Ambulatory Transport	\$35.00	\$2.50	\$10.00

- Mileage is calculated from the point of passenger pickup to the destination.
- Wait Time applies after the first 15 minutes of waiting at pickup or drop-off location.

2. Additional Charges

- After-Hours Service (Before 6 AM or After 8 PM): \$15.00 per trip
- Holiday Surcharge (Federal Holidays): \$20.00 per trip
- No-Show Fee: \$25.00 if not canceled at least 2 hours before scheduled pickup
- Extra Attendant (if requested): \$25.00 per trip

3. Payment Terms

- Payment is due upon service completion unless prior arrangements have been made.
- Accepted payment methods: Cash, Credit/Debit Card, Medicaid (if applicable), or Pre-approved Invoicing.

4. Service Area

Transportation services will be provided over irregular routes within the Washington Metropolitan Area Transit District, including:

- District of Columbia
- Montgomery and Prince George's Counties, Maryland
- Arlington and Fairfax Counties, and the Cities of Alexandria and Falls Church, Virginia
