Montgomery Charter Service, Inc., of Bethesda, Maryland, has filed an application for a Certificate of Public Convenience and Necessity to authorize:

a. Charter Operations.

Transportation by motor vehicle of passengers and their baggage from Montgomery County to all points within the Metropolitan District on the one hand, and on the other, transportation from all points within the Metropolitan District and without the Metropolitan District to all points in Montgomery County.

b. Sightseeing Operations.

Transportation by passenger vehicle of a person or group of persons, with several but common purpose, at a fixed charge per person from Montgomery County to all points of sightseeing interest within the Metropolitan District and return, over a predetermined route, or at an hourly rate per person over a route determined by the passenger group at, or after having left, the place of origin.

c. Contract Operations.

Transportation by motor vehicle of passengers and their baggage under continuing contracts with one individual, person, firm, copartnership, partnership, corporation, company, association, joint stock association, state, municipality, county or political subdivision, or the Federal Government for the furnishing of transportation services through the assignment of a motor vehicle for a continuing period of time to the exclusive use of each such persons and organizations as afore stated, or for the furnishing of transportation services designed to meet the distinct need of each individual or organization as afore stated, located in Montgomery County from and to any point in the Metropolitan District on the one hand, and on the

other hand, from all points in the Metropolitan District to any and all points in Montgomery County.

d. Airport Terminal Operations.

Transportation by motor vehicle of passengers and their baggage from any and all points in Montgomery County to Washington National Airport and to any point or points in Montgomery County, from Washington National Airport.

RESTRICTION:

Restricted, however, to the transportation of not more than fourteen (14) passengers in any one vehicle, but not including the driver thereof.

THEREFORE IT IS ORDERED:

1. That this application be set for hearing on Wednesday, December 20, 1961, at 10:00 a.m., in Hearing Room C, Interstate Commerce Building, 12th and Constitution Avenue, N.W., Washington D. C.
2. That notice of this application be published in three newspapers of general circulation in the Metropolitan District at least fifteen (15) days prior to December 20, 1961.
3. That protests to this application, in writing, shall be filed at least five (5) days prior to said hearing.
