On November 27, 1963, D. C. Transit System, Inc., filed an application to reroute its N-1 and N-2 bus routes at its northern terminal. Upon the receipt of several protests to the proposed change, the Commission decided to conduct a public hearing on the matter; whereupon D. C. Transit System, Inc., withdrew its application.

On January 2, 1964, the Commission received a request from the D. C. Highway Department for reconsideration of the proposed rerouting in order to comply with a traffic regulation prohibiting left turns at River Road and Western Avenue, N. W.

In addition, the terminal stand for the N-1 and N-2 routes on the north side of Ellicott Street, N. W., west of Wisconsin Avenue must be relocated due to construction of an enlarged driveway at that point.

The Engineering Department of the Commission has considered all of the above matters and proposes that bus routes N-1 and N-2 be rerouted between Western Avenue and River Road, N. W., and Jennifer and 44th Streets, N. W., so as to operate over the following streets:

From the intersection of Western Avenue and River Road, N. W., thence via Western Avenue, Wisconsin Avenue, Jennifer Street to the intersection of Jennifer and 44th Streets, N. W.; thence return via Jennifer Street and Western Avenue to the intersection of Western Avenue and River Road, N. W.

The Commission is of the opinion that all interested persons should have an opportunity to be heard with reference to the proposed rerouting of the N-1 and N-2 routes of the Massachusetts Avenue Bus Line of D. C. Transit System, Inc.

**THEREFORE, IT IS ORDERED:**

1. That an investigation be made and a hearing held concerning the propriety and reasonableness of the proposed rerouting of the N-1 and N-2 bus routes of D. C. Transit System, Inc.


2. That this matter be, and it is hereby, set for hearing on Thursday, February 20, 1964, at 9:30 A. M., at the offices of the Commission, 1801 North Moore Street, Arlington, Virginia.

3. That D. C. Transit System, Inc., post notice of the subject matter of this hearing, and of the time and place thereof, in all buses operated over the affected routes.

4. That a copy of this order be sent to all known interested persons.

5. That the Chief Clerk shall publish notice of this hearing in a newspaper of general circulation in the Metropolitan District at least twenty-five (25) days prior to said hearing.
