By Applications Nos. 537 and 538, filed November 4, 1968,
~~A. B. & W. Transit Company requests authority to extend Route~~
16 and add Route 18D as follows:

Application No. 537 - Route 16

Discontinued Portion

From Heritage Drive and Americana Drive over Americana Drive to the Americana-Fairfax Apartment's Parking Lot and return via Parking Lot to Americana Drive and Heritage Drive.

Rerouted Portion

Outbound - Continue on Heritage Drive to north entrance of Heritage Mall Shopping Center on North Road, right on North Road approximately one hundred feet to terminal stand.

Inbound - Leave terminal stand on North Road to roadway in rear of Heritage Mall Shopping Center, left on rear roadway to Americana Drive on southside of Shopping Center, left on Americana Drive to Heritage Drive, left on Heritage Drive to Route 236, thence over regular route.

Application No. 538 - Route 18D

Inbound - To Washington

From Keene Mill Road and Greeley Boulevard, thence in a counter clockwise direction via Greeley Boulevard, left on Carrleigh Parkway, right on Keene Mill Road, left on Rolling Road, left on Greeley Boulevard, right on Keene Mill Road, left on Hanover Avenue, thence over regular route to Washington via Shirley Highway, by-passing Bren Mar Park.

Outbound - From Washington


Over regular route from Washington via Shirley Highway, by-passing Bren Mar Park, thence to Keene Mill Road and Hanover Avenue, right on Keene Mill Road, right on Greeley Boulevard, left on Carrleigh Parkway, right on Keene Mill Road, left on Rolling Road, left on Greeley Boulevard to Keene Mill Road.

The law requires a public hearing be held on these matters.

THEREFORE, IT IS ORDERED:

1. That these matters be, and they are hereby, scheduled for public hearing on Thursday, December 12, 1968, at 10:00 A.M., in the Hearing Room of the Commission, 1815 North Fort Myer Drive, Arlington, Virginia 22209.
2. That applicant publish notice of these applications and the hearing thereon in a newspaper of general circulation in the Metropolitan District, once, at least twenty-five (25) days prior to said hearing.
3. That any interested person desiring to be heard on these matters shall so indicate in writing to the Commission, with a copy to Mr. M. A. Bresnahan, Traffic Manager, A. B. & W. Transit Company, 600 N. Royal Street, Alexandria, Virginia 22314 at least fifteen (15) days prior to said hearing.
