Commission Regulation No. 58 requires respondent to insure the revenue vehicles operated under Certificate No. 957 for a minimum of \$1.5 million in combined-single-limit liability coverage and maintain on file with the Commission at all times proof of coverage in the form of a WMATC Certificate of Insurance and Policy Endorsement (WMATC Insurance Endorsement) for each policy comprising the minimum. Under Regulation No. 67-03(c), \$50 shall be due and payable upon the failure of a carrier to timely file an acceptable WMATC Insurance Endorsement.

The \$1.5 million primary WMATC Insurance Endorsement on file for respondent was cancelled on January 6, 2006, effective February 13, 2006, and has not been replaced. Certificate No. 957, therefore, is automatically suspended.

In addition, respondent has neither paid the \$150 annual fee for 2006 nor filed its annual report for 2005/2006. Under Regulation Nos. 67-02 and 67-03(b), \$100 shall be due and payable upon the failure of a carrier to pay an annual fee by January 31.<sup>1</sup> Under Commission Regulation Nos. 60-01 and 67-03(a), \$100 shall be due and payable upon the failure of a carrier to file an acceptable annual report by January 31.<sup>2</sup>

Respondent shall have thirty days to file the necessary endorsement(s), pay the \$150 annual fee for 2006, submit an annual report for 2005/2006, and pay \$250 in late fees or show cause why Certificate No. 957 should not be revoked.

THEREFORE, IT IS ORDERED:

1. That respondent shall not transport passengers for hire under Certificate No. 957, unless and until otherwise ordered by the Commission.

2. That within thirty days, respondent shall file the necessary WMATC Insurance Endorsement(s), submit an annual report for 2005/2006, and pay by money order, certified check, or cashier's check the \$150 annual fee for 2006, and the sum of \$250 in late fees, or show cause why Certificate No. 957 should not be revoked pursuant to Article XI, Section 10(c), of the Compact.
