This rulemaking was announced in Order No. 13,085, served December 15, 2011, for the purpose of soliciting comments on proposed amendments to the Commission's Rules of Practice and Procedure and Regulations,¹ Regulation No. 67, which lists the Commission's various fees.

Order No. 13,085 was posted to the Commission's website, www.wmatc.gov, on December 15, 2011, and has remained posted there since then. Copies were served on all carriers holding WMATC authority on that date.

The 30-day comment period announced in Order No. 13,085 has closed. No comments were received. The proposed amendments therefore shall be adopted.

Said amendments will have the effect of increasing the Commission's late fees, adding a dishonored payment fee, and codifying the fees for reproducing and certifying Commission records that the Commission has been charging since 1991 but which have not been published by order or regulation.

I. LATE FEES

Commission Regulation No. 67 is amended by replacing current Regulation No. 67-03 with the following text.

"67-03. Late fees. The following late fees shall be due and payable upon the failure of a carrier to:

- (a) Timely file an annual report -- \$150.
- (b) Timely pay an annual fee -- \$150.
- (c) Timely file a WMATC Insurance Endorsement -- \$100."

II. DISHONORED PAYMENT FEE

Commission Regulation No. 67 is amended by inserting the following text after Regulation No. 67-05.

"67-06. Dishonored payment fee. A \$25 fee shall be charged for each payment made to the Commission by check, money order, credit card, or debit card that is later returned, reversed, or otherwise dishonored."

III. REPRODUCTION AND CERTIFICATION FEES

Commission Regulation No. 67 is amended by inserting the following text after Regulation No. 67-06.

"67-07. Reproduction and certification fees.

Copies of records (per side)	\$0.25
Certificate of authenticity	5.00
Certificate of good standing	5.00
Duplicate certificate of authority	10.00"

THEREFORE, IT IS ORDERED: that the foregoing amendments to the Commission's Rules of Practice and Procedure and Regulations are hereby adopted, effective January 31, 2012.
