By letter dated July 18, 2012, applicant was notified of acceptance of the above-captioned applications and directed to submit additional information in accordance with Regulation No. 54-04(b), including:

- evidence of applicant's alleged U.S. DOT registration;
- evidence of applicant's alleged passenger carrier authority from the Maryland Public Service Commission;
- the temporary authority information required by Regulation No. 54-06(a);
- a statement regarding the failure of one of applicant's affiliates, Reliable Limousine Service, LLC, to pay a civil forfeiture of \$1,750 assessed in WMATC Order No. 12,942, served August 11, 2011;
- a statement regarding the failure of said affiliate to verify as of August 2011 in accordance with WMATC Rule No. 28 cessation of operations requiring WMATC authority; and
- an affidavit stating whether and to what extent applicant and applicant's affiliates conducted passenger transportation service between points in the Washington Metropolitan Area after August 2011.

The July 18 letter cautioned applicant that failure to address these issues would result in delay or dismissal of the application. Applicant has yet to respond.

Under the Compact, an application to obtain a certificate of authority shall be made in writing, verified, and shall contain the information required by the application form and accompanying instructions.<sup>1</sup> An applicant may be required to publish notice of the

application in a newspaper of general circulation in the Metropolitan District and furnish any supplemental information necessary for a full and fair examination of the application.<sup>2</sup> Failure to comply with the Commission's application requirements warrants dismissal.<sup>3</sup>

THEREFORE, IT IS ORDERED: that the applications of Reliable Limousine and Bus Service, LLC, for a certificate of authority and temporary authority are hereby dismissed without prejudice for want of prosecution.
