Case No. MP-2013-073

Certificate No. 1553 was automatically suspended in Case No. MP-2013-063 on May 2, 2013, pursuant to Regulation Nos. 60-03 and 67-04, as a result of respondent's failure to file a 2013 annual report under Regulation No. 60-01 and pay a \$150 annual fee under Regulation No. 67-02, respectively, on or before May 1, 2013. Certificate No. 1553 was further suspended in Case No. MP-2013-063 on May 3, 2013, pursuant to Regulation No. 67-04, as a result of respondent's failure to pay \$300 in associated late fees under Regulation No. 67-03(a),(b) on or before May 2, 2013. Order No. 13,893, served May 3, 2013, gave respondent until June 3, 2013, to file the annual report and pay said fees or face revocation of Certificate No. 1553. Respondent has yet to comply.

In the meantime, Certificate No. 1553 became further suspended in Case No. MP-2013-073 on May 15, 2013, pursuant to Regulation No. 58-12, and a \$100 late insurance fee became due and payable under Regulation No. 67-03(c), when the \$1.5 million primary WMATC Insurance Endorsement on file for respondent terminated without replacement. Order No. 13,945, served May 15, 2013, gave respondent until June 14, 2013, to file the necessary WMATC Endorsement(s) and pay the \$100 late insurance fee or face revocation of Certificate No. 1553. Respondent has yet to comply.

Certificate No. 1553 shall be revoked pursuant to Article XI, Section 10(c), of the Compact for respondent's willful failure to comply with Commission Regulation Nos. 58, 60, and 67 and Commission Order Nos. 13,893 and 13,945. The report and \$550 in unpaid fees shall remain due.

THEREFORE, IT IS ORDERED:

1. That Case Nos. MP-2013-063 and MP-2013-073 are hereby consolidated under Rule No. 20-02.

2. That Certificate of Authority No. 1553 is hereby revoked.

3. That respondent's 2013 annual report and \$550 in fees shall remain due under Regulation Nos. 60 and 67, respectively.

4. That within 30 days from the date of this order respondent shall:

- a. remove from respondent's vehicle(s) the identification placed thereon pursuant to Commission Regulation No. 61;
- b. file a notarized affidavit and supporting photograph(s) with the Commission verifying compliance with the preceding requirement; and
- c. surrender Certificate No. 1553 to the Commission.
