This matter is before the Commission on applicant's request for an extension of time to comply with Commission Order No. 14,584, served February 21, 2014, and on applicant's request to add a trade name appearing on the certificate of authority that may issue if the extension is granted.

Order No. 14,584 conditionally granted Certificate of Authority No. 2460 and stipulated that applicant would have the full 180 days available under Commission Regulation No. 66, or until August 20, 2014, under Rule No. 7-01, to satisfy the conditions of the grant. On August 20, 2014, applicant requested an extension of the deadline.

Regulation No. 66-01 states: "Except as provided in Regulation No. 66-02, the time for complying with the conditions of a grant of authority shall not be extended beyond 180 days from the date of the grant. A conditional grant of authority shall be void on the 181st day following the date of the grant if full compliance has not been achieved at that time." Regulation No. 66-02 states: "Upon timely request for an extension of the 180-day deadline in Regulation No. 66-01, the Commission's Executive Director may grant a maximum extension of 31 days." The request having been timely filed, an extension of 31 days shall be granted, and applicant shall have until September 22, 2014, to satisfy the conditions of the grant stipulated in Order No. 14,584.

Also on August 20, 2014, Perfect Fit Home Care, LLC, filed an application to add the trade name "Perfect Fit Transportation" to the yet to be issued Certificate No. 2460.

Under Regulation No. 54-08, the Executive Director may approve an application to change a trade name. A trade name application shall include proof of trade name registration in the jurisdiction where applicant's principal place of business is located. In the case of an

applicant whose principal place of business is outside the District of Columbia, Maryland, or Virginia, the Commission will accept a registration certificate from the jurisdiction in the Metropolitan District where applicant's local office or designated agent for service is located.

Applicant's principal place of business is located in Maryland. The application is supported by proof of registration of the new trade name with the Maryland Department of Assessments and Taxation. Accordingly, the application shall be conditionally approved.

THEREFORE, IT IS ORDERED:

1. That Case Nos. AP-2014-030 and AP-2014-252 are hereby consolidated under Rule No. 20-02.

2. That applicant shall have until September 22, 2014, to satisfy the conditions of the grant stipulated in Order No. 14,584.

3. That upon applicant's compliance with the requirements of Order No. 14,584 on or before September 22, 2014, Certificate of Authority No. 2460 shall be issued to Perfect Fit Home Care, LLC, trading as Perfect Fit Transportation, 120 Stan Fey Drive, Upper Marlboro, MD 20774-8735.
