This matter is before the Commission on respondent's failure to respond to Order No. 15,071, served September 18, 2014, directing respondent to show cause why the Commission should not revoke Certificate No. 2482.

This matter arises out of the Commission's approval of the application of Asim Sherzai, (respondent), for a WMATC certificate of authority on April 9, 2014, in Order No. 14,684, which approval was subject to the condition, among others, that respondent produce a copy of the for-hire vehicle registration card for each vehicle to be operated under WMATC authority, as required by WMATC Regulation No. 64-04.¹

On May 30, 2014, respondent having satisfied all conditions stipulated in Order No. 14,684, except the for-hire plate condition, the Commission issued WMATC Certificate No. 2482 to respondent, ordered respondent's sole WMATC vehicle out of service, and gave respondent 30 days to obtain for-hire plates for that vehicle or face revocation of Certificate No. 2482.

As of September 18, 2014, respondent had yet to demonstrate success in obtaining for-hire plates. Order No. 15,071 accordingly directed respondent to show cause why the Commission should not revoke Certificate No. 2482.

Thereafter on October 16, 2014, Certificate No. 2482 became automatically suspended under Regulation No. 58-12 for respondent's willful failure to maintain compliance with the insurance requirements specified in Regulation No. 58. Order No. 15,123, served October 16, 2014, noted that Certificate No. 2482 would be subject to revocation if respondent failed to file the necessary insurance endorsement(s) and pay a \$100 late fee within 30 days. Respondent failed to comply, and Certificate No. 2482 was revoked on December 30, 2014, in Order No. 15,252.²
