This rulemaking was announced in Order No. 15,316, served January 9, 2015, for the purpose of soliciting comments on proposed increases in certain of the Commission's fees listed in Commission Regulation No. 67.¹

The Commission's filing fees and annual license fee have not changed since 2005. Certain miscellaneous Commission fees have not changed since 1991. The appendix attached to Order No. 15,316, reveals the extent to which inflation has eroded the value of these fees as measured in constant dollars.²

Order No. 15,316 was posted to the Commission's website on the pending proceedings page³ on January 9, 2015, and remained posted there beyond the 30-day comment period announced in Order No. 15,316.

The 30-day comment period has closed. No comments were received. The fee increases proposed in Order No. 15,316 therefore shall be adopted without change. The existing fees (Old) and the new fees (New) are as follows.
