On August 17, 2016, Certificate No. 2831 was automatically suspended pursuant to Regulation No. 58-12 for the failure of City Flier Shuttle & Car Service LLC to maintain on file with the Commission proof of \$1.5 million in combined-single-limit, motor vehicle liability insurance as required by Commission Regulation No. 58.

Order No. 16,526, served August 17, 2016, noted that Certificate No. 2831 would be subject to revocation if City Flier Shuttle & Car Service LLC failed to file the necessary insurance endorsement(s) and pay the \$100 late fee due under Regulation No. 67-03(c) within 30 days. Instead of complying with Order No. 16,526, City Flier Shuttle & Car Service LLC filed an application requesting voluntary termination of Certificate No. 2831 on September 16, 2016.

The Executive Director may approve an application for voluntary termination under Regulation No. 54-08(d). The application shall be denied if applicant is not in good standing with the Commission.<sup>1</sup>

Because City Flier Shuttle & Car Service LLC has not paid the \$100 late fee, it is not in good standing with the Commission. Because City Flier Shuttle & Car Service LLC is not in good standing with the Commission, the application for voluntary termination shall be denied.<sup>2</sup>

Because City Flier Shuttle & Car Service LLC failed to file the necessary insurance endorsement(s) and pay the \$100 late fee on or

before September 16, 2016, Certificate No. 2831 shall be revoked pursuant to Regulation No. 58-15(a).

THEREFORE, IT IS ORDERED:

1. That Case Nos. AP-2016-155 and MP-2016-135 are hereby consolidated pursuant to Commission Rule No. 20-02.

2. That the application of City Flier Shuttle & Car Service LLC for voluntary termination of Certificate No. 2831 is hereby denied.

3. That Certificate of Authority No. 2831 is hereby revoked.

4. That the \$100 late insurance fee due under Regulation No. 67-03(c) shall remain due.

5. That within 30 days from the date of this order City Flier Shuttle & Car Service LLC shall:

- a. remove from respondent's vehicle(s) the identification placed thereon pursuant to Commission Regulation No. 61;
- b. file a notarized affidavit with the Commission verifying compliance with the preceding requirement; and
- c. surrender Certificate No. 2831 to the Commission.
