By motion, filed May 24, 1974, counsel for D. C. By motion, filed May 10, 1974, counsel for Leonard N. Bebchick, et al., requested the Commission to extend the time for filing statements and motions until May 28, 1974, and the time for filing responses thereto until June 11, 1974. That motion was granted by Order No. 1326, served May 13, 1974.

The Commission is of the opinion that the motion of counsel for D. C. Transit System, Inc., should be granted.

THEREFORE, IT IS ORDERED:

1. That the "Motion by D. C. Transit System, Inc. for Postponement of Filing Dates" filed May 24, 1974, be, and it is hereby, granted.

That the filing date of May 28, 1974, for the filing of statements and motions, and the filing date of June 11, 1974, for the filing of responses thereto fixed by the Commission by Order No. 1326, served May 13, 1974, be, and they are hereby, postponed until June 11, 1974, for the filing of statements and motions, and June 25, 1974, for the filing of responses thereto.
