Pursuant to Order No. 1385, served December 2, 1974, a hearing on the subject application was commenced on January 16, 1975. As required by that order, the applicant presented in evidence an affidavit attesting to newspaper publication of a notice of the application and the public hearing. The Washington Metropolitan Area Transit Authority appeared in opposition.

Order No. 1385 required, among other things, that applicant file specified statements and exhibits prior to the public hearing. The applicant did not file the statements and exhibits. At the public hearing, the counsel for applicant stated that neither the applicant nor its counsel was served a copy of Order No. 1385. The records of the Commission do not indicate that service was effected.

The administrative law judge presiding on behalf of the Commission at the public hearing directed the applicant and protestant to develop the record with respect to all matters other than the financial condition of the applicant. At the close of the submissions of evidence, the administrative law judge adjourned the hearing until February 11, 1975 at 9:30 a.m. In addition, the administrative law judge stated that an order would be served fixing the time for filing the financial statements and exhibits.

The applicant shall be required to submit and be prepared to support with competent witnesses the following financial

exhibits:

- (A) A detailed balance sheet of applicant as of December 31, 1974,
- (B) A detailed income statement of applicant for the 12-month period ending December 31, 1974, and
- (C) A statement projecting revenues and revenue deductions, including taxes, allocated between the contract with Parklawn Commuters Club and other operations, for a one-year period, together with supporting details, including the ratio between revenue deductions and revenues.


Applicant shall be directed to file six(6) copies of the statements and exhibits required hereinbefore with the Commission and serve one copy on each party of record on or before Friday, February 7, 1975.

THEREFORE, IT IS ORDERED:

1. That Application No. 850 of McMichael School Bus Service, Inc., be, and it is hereby, scheduled for continued hearing to commence Tuesday, February 11, 1975, at 9:30 a.m., in the Hearing Room of the Commission, Room 314, 1625 I Street, N.W., Washington, D.C. 20006.

2. That six(6) copies, the original to be submitted at the hearing, of the statements and exhibits required hereinbefore be filed by McMichael School Bus Service, Inc., with the Commission and one copy served on each party of record on or before Friday, February 7, 1975.
