By Order No. 2221, served April 30, 1981, the Commission suspended WMATC Tariff No. 12 of Airport Limo, Inc., which otherwise would have become effective on May 1, 1981. The suspension was ordered to permit determination of the appropriateness of certain operating expenses.

Upon review of supplemental material filed by applicant the staff of the Commission proposed to disallow certain expenses paid for purchased transportation, and suggested a proportional reduction in the revenues to be produced under the proposed tariff. As a result applicant suggested reducing certain rates originally contained in its proposed tariff in order to produce a just and reasonable return in accordance with the provisions of Title II, Article XII, Section 6 of the Compact. Accordingly, the suspension shall be terminated and the proposed rates, as set forth below, will be allowed to take effect on three-days' notice from the acceptance by the Commission's Executive Director of a revised WMATC Tariff No. 12, containing only the rates specified below.

THEREFORE, IT IS ORDERED:

1. That Airport Limo, Inc., is hereby directed to file a revised WMATC Tariff No. 12 containing only the approved rates specified above to become effective at 12:01 a.m. on the third day following acceptance of said revised tariff by the Executive Director.

2. That the suspension of WMATC Tariff No. 12 of Airport Limo, Inc., is terminated simultaneously with the effective time of the revised tariff.

3. That Airport Limo, Inc., is directed to post continuously and conspicuously for a period of one week in each of its vehicles notice of this action and the fares authorized thereby no later than one day from the date of service of this order.
