On April 1, 2004, Calvin Irick, trading as Irick's Transportation, filed an application requesting voluntary termination of Certificate No. 784.

On April 10, 2004, while the voluntary termination application was pending, Certificate No. 784 was automatically suspended pursuant to Regulation No. 58-02 for Irick's willful failure to maintain on file with the Commission proof of \$1.5 million in combined-single-limit, motor vehicle liability insurance as required by Commission Regulation No. 58.

On April 12, 2004, in Order No. 7936, the Commission served notice on Irick that Certificate No. 784 would be subject to revocation if Irick failed to file the necessary WMATC Insurance Endorsement(s) within thirty days.

Because Irick is not in good standing with the Commission, having neither paid the \$100 annual fee for 2004¹ nor filed his annual report for 2003,² we shall deny the application for voluntary termination. Because Irick has failed to file the necessary WMATC Insurance Endorsement(s), we shall revoke Certificate No. 784 pursuant to Article XI, Section 10(c), of the Compact for Irick's willful failure to comply with Regulation No. 58; provided, that the unpaid \$100 annual fee for 2004 shall remain due and payable; and further provided, that the unfiled 2003 annual report also shall remain due.

THEREFORE, IT IS ORDERED:

1. That the application for voluntary termination is denied.
2. That Certificate of Authority No. 784 is hereby revoked.
3. That within 30 days from the date of this order Irick shall:
 - a. remove from Irick's vehicle(s) the identification placed thereon pursuant to Commission Regulation No. 61;
 - b. file a notarized affidavit with the Commission verifying compliance with the preceding requirement; and
 - c. surrender Certificate No. 784 to the Commission.
