RULES, REGULATIONS, AND PRACTICES
FOR ALEXANDRIA TRANSIT COMPANY (ATC)
CHARTER BUS OPERATIONS

1. The ATC charge for charter bus operations is \$50.00 per hour, per bus.
 - a. Minimum charge of one hour for each operation in the City of Alexandria, and a minimum charge of two hours for each operation in the District of Columbia and Maryland.
 - b. Time over two hours shall be calculated on a half hour basis at a rate of \$25.00/half hour. Any time over the 30 minute interval shall be charged for the entire 30 minutes.
 - c. Time to calculate charter charge shall be based on the time the bus leaves the ATC garage until the time it returns to the ATC garage, located at 116 South Quaker Lane, Alexandria, Virginia.
2. The ATC charter charge shall apply to all charter operations within its operating jurisdiction.
3. Times for charter services, allowing for bus availability, shall generally be as follows:
 - a. Weekdays, Saturdays and Sundays: 6:00 AM - 1:00 AM
