Day:

Minimum six (6) hours which includes one (1) hour commuting to and from the pickup and drop off site.

16 and more passengers \$75.00 per hour plus 15% gratuity

(E) Cancellation Policy

1. Cancellations must be made 24 hours in advance. Cancellations within 24 hours are non refundable.

2. Individual tours require a credit card confirmation to reserve a tour. Payment is made in full by cash, credit card or traveler's check at the time of the tour.
