

**SECTION I
SCOPE OF OPERATIONS**

First Transit, Inc. is granted authority to transport passengers, over irregular routes, in charter operations between points in Metropolitan District, as specified in Certificate of Authority No. 157.

**SECTION II
RATES AND CHARGES**

Rate per hour of service is \$47.50 or fraction. Rate to be charged for the time bus is in service for the customer including all deadhead time to and from the garage and any waiting time.

A minimum of \$95.00 will be charged for all charters.

Cancellations will be accepted without penalty up to 24-hours in advance of the event.

Cancellations less than 24-hours in advance will result in a penalty of \$47.50.

Customers not showing at the prearranged pickup point or who cancel at the pick up point will be charged a cancellation penalty of \$95.00.
