RULES AND OTHER GOVERNING PROVISIONS

Animals and Birds

Animals and birds will not be transported.

EXCEPTION: Trained and properly identified (such as harness, leash, ID tags, etc.) assistance (or service) animals traveling with persons who are blind, deaf, hard of hearing or disabled shall be transported.

Baggage

Baggage will not be checked. Personal baggage, musical instruments, athletic equipment and other paraphernalia necessary for the purpose of the charter trip and limited to the capacity of the chartered vehicle will be transported in custody of the chartering party at no additional charge.

Claims

Except as otherwise prescribed by law, all claims must be filed in writing with the carrier and processed in accordance with 49 CFR 1005 and 1008.

Damage to Vehicle

The charter contracting party will be held responsible for any damage to coach or coach equipment caused by its passenger.

Delays

The company shall not be liable for delays caused by accidents, breakdowns, road conditions, storms and other circumstances beyond its control.

Equipment Points

Equipment available will be stored at 7479 New Ridge Road, Hanover, Maryland 21076.

RULES AND OTHER GOVERNING PROVISIONS

Hazardous or Potentially Dangerous Circumstances

In the interest of safety of passengers, the driver, and the vehicle, the Company reserves the right, for good cause to refuse to book or contract for a movement and the Company shall not be responsible for (1) cancellation of a planned movement or (2) for refusal of its drivers to operate a vehicle on a movement in its entirety or over a part of its planned routing, under the conditions and situations set forth below, and the right is reserved for the driver alone to be the judge of such circumstances when encountered while the movement is enroute:

1. Hazardous or dangerous roads, driveways, bridges, parking areas, camp sites, private grounds, etc.
2. A picketed or forbidden place or any place under situations where violence or rioting exists, is threatened, or reasonably may be anticipated.

The Company will however, when practicable, endeavor to cooperate with the passengers in revising the routing so as to avoid any circumstances described above when encountered while the movement is enroute.

Objectionable Persons

Carrier reserves the right to refuse to transport a person or persons under the influence of intoxicating liquors or drugs or who is incapable of taking care of himself or herself, or whose condition is such as to make him or her objectionable to other passengers, the driver or the vehicle.

EXCEPTION: This rule does not apply to persons who are ill or accompanied by an attending nurse.

Payment of Charges

A deposit of \$100.00 per vehicle will be required within two (2) weeks of reservation. All balances are payable on or before the departure date.

Refunds and Cancellation

There will be a thirty (30) day cancellation charge for each chartered vehicle reserved. If the carrier is notified more than thirty (30) days prior to charter date, the deposit will be refunded in full. If cancellation is made within thirty (30) days of charter date, the deposit will be forfeited.

RULES AND OTHER GOVERNING PROVISIONS

Tolls, Parking Charges, and Driver Expenses

Fares and charges contained herein do not include parking, bridge, ferry, tunnel, or highway tolls, charges for special licenses in cities or states, or entrance charges to any particular place. Additional charge or charges shall be assessed as provided and published by the regulatory bodies governing the tolls or charges applying for passage over bridges, ferries, highways, or charges for parking or special licenses.
