

Waiting Time for 5 passenger Sedan \$53.10 per hour charged at 15 minute increments.

Coordinator service- \$30 per hour minimum 4 hours

Professional Guide service- Professional guide rate plus 20%

Translator service- Translator rate plus 20%

To avoid cancellation charges, 24 hour cancellation is required for 5 passenger sedans,

1 week for 15 passenger van and 8 passenger stretch limousines.
