Table of charges

The following charges will be assessed for each vehicle chartered, per hour or portion thereof subject to minimum charges

Rate per Hour

January 1 thru
December 31

55 Passenger Coach \$95.00

Time is to be calculated from time the charter coach arrives at the scheduled pick up location at the beginning of the charter trip until it drops off the charter group at the conclusion of the charter trip plus one additional hour for Garage/Travel time. Time is calculated as per hour or portion thereof.

Minimum Charge

A minimum of five hours at the hourly rate per coach will be assessed when the application of the charges listed above does not equal that amount.

Transfers

At chartering party's request, carrier will provide Transfer Service from one point to a second point, both within the Washington Metropolitan District, at charges shown below

The chartering party shall have 30 minutes free time after the pick up time it has specified to board the coach. If the chartering party is not ready for the coach to depart within the 30 minute free time, carrier shall assess for waiting time an additional charge of \$85.00 per hour or portion thereof.
