

- ii. Extra baggage, musical instruments, athletic equipment, large and extra long items could be assessed additional charge at the discretion of the carrier.
- iii. Liability for loss or damage of baggage will be limited to Seventy dollars (\$70.00) for each passenger if such loss is due to the fault or negligence of the carrier.

#### **B. Objectionable Persons**

Carrier reserves the right to refuse services to individual it deems disruptive to normal operations of transportation. Objectionable individuals include a person under the influence of alcohol or drugs, someone who is mentally unstable, which makes him or her objectionable to other passengers and the driver. An objectionable person includes individuals who are incapable of taking care of himself / herself because of a medical condition.

EXCEPTION: The above rules do not apply to a person who is ill and is accompanied by an attendant nurse. Carrier will assist physically challenged individuals to the best of its capabilities.

#### **C. Animals**

No animals of any type will be carried, except seeing eye, medically required or law enforcement dogs accompanied by their master.

#### **Carrier's Liability**

- a) Carrier will not be liable for delays caused by natural disasters, public disturbances, and authority of law, quarantine, traffic, riots, strikes, accidents, breakdowns, bad conditions of the road such as snowstorms or road closures and other conditions beyond its control. Carrier does not guarantee to arrive at or depart from any point at a specified time. Carrier is committed to maintaining the time schedule submitted by its agents or employees, but it is not **guaranteed**.
- b) If any condition(s) mentioned in subsection (a) above makes it impossible for the carrier to provide service in the opinion of the carrier either from the place of origin or any point en route or at the destination the carrier shall not be liable or caused to be held liable for damages, missed flights, or for any reason whatsoever.
