

I-Points in the Washington metropolitan area transit district

II-Rate and charge

Time is calculated from the time the charter vehicle arrives at the scheduled pickup point at the beginning of the charter trip until it drops off

A-(bus 25 pass). 4 hour minimum..... \$75/hour

B-(bus 35 pass). 4 hour minimum.....\$85/hour

C-(limo bus 20 pass) 4 hour minimum.....\$120/hour

III-transfer Rates (one way)

TO or From	Bus 25 pass	Bus 35 pass	limo Bus 20 pass
Dulles Airports	\$300	\$400	\$500
National Airport	\$250	\$350	\$450


1-Volume discount:

Any customer utilizing carriers services in an amount of \$700 or more in any fourteen day period will receive a discount of ten percent (10%)off the otherwise applicable tariff rate such as services.

Other charges- 1- (20 % surcharge is added to each bill for drivers gratuity.

2- Waiting time is charged at a rate of 75 cents per minute after the first 10 minute

3-For an additional charge of \$20 carriers drivers will (meet and greet)customer at airports.



III- Rules and regulations

A--Baggage---baggage will not be checked, personal baggage, musical instruments, athletic equipment, and other paraphernalia limited to the capacity of the vehicle will be transported in custody of the passenger at no additional charge. carrier assumes no responsibility or liability for such personal baggage and/or property transported by it.

B-- Liability- If any act of God, public enemies, authority of law ,quarantine perils of navigation, riots, strikes, the hazards or dangers incident to a state of war ,accidents, break downs ,bad condition of the road storms or other conditions beyond its control ,make it in the opinion of the carrier ,inadvisable to conduct operations carrier shall not be liable therefore. carrier does not guarantee to arrive or depart from any point at a specified time ,but will endeavor to maintain the schedule submitted by its agent or employee.

C--OBJECTIONAL PERSON-- Carrier reserves the right to refuse to transport a person or persons under the influence of intoxicating liquor or drugs or who is incapable of taking care of himself or herself ,or whose conduct is such or is likely to be such as to make him or her objectionable to other passengers Exceptional :this rule does not apply to persons who are ill and are accompanied by an attendant or nurse .

D-- Cleaning charge --- if any the opinion of carrier ,any passenger or passengers so foul(s) the vehicles as render it to be in a particularly dirty condition ,a cleaning charge \$100 will be charged against that passenger or passengers.

E- Damage charge--- Vehicle are carefully inspected by carrier prior to each trip .Any damage to seats ,window, or other equipment or parts of the vehicle which is caused by any passengers shall be responsibility of the passengers and the cost to carrier for repairs of such damage shall be paid by the passengers .

F-- Tool .Fees and Charge--the charge herein do not include bridges ,ferry ,tunnel, or highway, tolls entrance fee or charge for special licenses or permit .An additional charge will be assessed for the cost of any such tool, fee or special charge.

G--Cancellations--cancellations made more than 48 hours but less than 10 days prior to departure will assessed A \$200 cancellation fee. If within 48 hours made will be \$300

H -- Payment of charge and fee; payment of all charges and fees shall be the responsibility of the person or organization chartering the bus .the carrier reserve the right to collect such charges in advance unless prior credit arrangement have been made with the carrier.
